TEAM REGISTRATION DEADLINE AND PAYMENT – 15 JANUARY 2023

a) Application criteria

UCI MTB CROSS-COUNTRY TEAM can apply for a registration only if the team is ranked with a total of minimum 75 points in the UCI endurance team ranking. The ranking is calculated as per the rules and based on the riders individual UCI points in the first UCI XCO individual ranking of the season.

UCI MTB DOWNHILL TEAM can apply for a registration only if the team is ranked with minimum 1 point in the gravity team ranking. The ranking is calculated based on the final individual DHI UCI World Cup standings of the previous year and the DHI UCI World Championships results by attributing points as per the table in the rules.

UCI MTB MARATHON TEAM can apply for a registration without any points requirements.

UCI MTB ENDURO TEAM can apply for a registration only if the team is ranked with 1 point in the gravity team ranking calculated as per the rules. The ranking is calculated using the best three rider’s results at each Enduro World Series round.

All teams must submit their application and pay the standard fee. Payment should mention **UCI MTB TEAM: “TEAM NAME”**.

b) General information

In addition, we also remind you that:

- a rider cannot be considered as a team manager or staff member of a UCI MTB Team.
- the general email address of the team should not be the same as a rider’s email.
- a team must imperatively have a team manager to be registered.

1. Team Name

The “2022 TEAM NAME” field is prefilled-in with the current team name registered with the UCI and cannot be modified.

The “2023 TEAM NAME” field must be filled-in with the team name you wish to use for the 2023 season.

The “TEAM CODE (3 characters upon availability)” field must be filled-in with the team three-letter code you wish to use for 2023 season.

When this information is saved as draft or submitted, the team name and team code are updated and displayed on your dashboard.

2. Person in charge of the registration

When this information is saved as draft or submitted, it is updated and displayed on your dashboard (highlighted in light yellow).

3. Details of the UCI team that will be published on UCI website

Data is pre-filled in from previous season. Please make sure to check and update the information if needed before submitting. Please make sure to enter the absolute URL, including the leading <http://> or <https://> (example: <http://www.example.com>).

Please note that this information will be displayed on the UCI website and therefore, visible to anyone checking the website.

4. Main sponsors

If you have several main sponsors (up to two), please make sure to fill-in the first main sponsor before filling-in the second main sponsor. When this information is saved as a draft or submitted, it is updated and displayed on your dashboard below the team category.

To ensure the integrity and image of cycling, the UCI has identified several categories of sponsors with whom stakeholders, including teams, may not be associated (directly or indirectly). Thus, article 1.1.089 of the UCI Regulations provides that:

“Without prejudice of the applicable law, no brand of tobacco, spirits, pornographic products or any other products that might damage the image of the UCI or the sport of cycling in general shall be associated directly or indirectly with a licence-holder, a UCI team or a national or international cycling competition.

As defined in the present article, a spirit is a beverage with a content in alcohol of 15% or more.”

In addition, article 1.1.090 of the UCI Regulations lays down certain conditions in relation to sponsorship by betting companies (including national lotteries). These conditions protect the integrity of cycling by reducing the risk of collusion and ensuring that visibility on cycling events is exclusively granted to betting operators whose activity does not cause a risk to the integrity of the sport.

The team seeking sponsorship by a betting company shall provide documentation establishing compliance with the conditions laid down in article 1.1.090 of the UCI Regulations with its request for registration before the UCI (the same applies in case the sponsorship is considered after the registration has been confirmed). We invite you to read this article carefully and remain at disposal.

5. Paying agent

Data is pre-filled in from previous season. Please make sure to check and update the information if needed before submitting. Please make sure to enter the absolute URL, including the leading <http://> or <https://> (example: <http://www.example.com>).

LIST OF STAFF MEMBERS - 15 JANUARY 2023

There are two different sections in this task: list of licensed staff and list of non-licensed staff. All staff members contracted by the team, including on a temporary basis, licensed or non-licensed, must be registered in one of both lists.

Staff members who have a management role (Team Manager, Assistant Team Manager) must be licensed. We recommend that other staff members are licensed, but it is not mandatory.

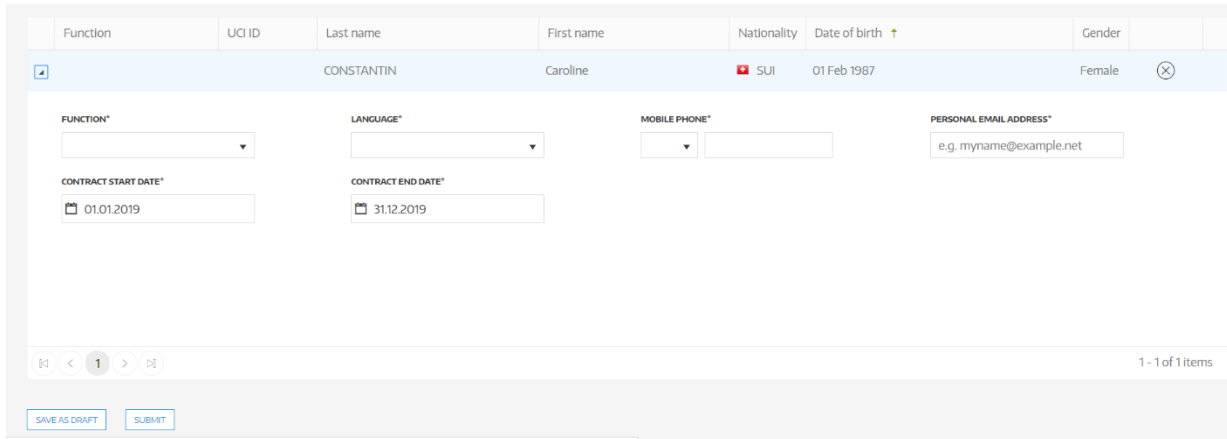

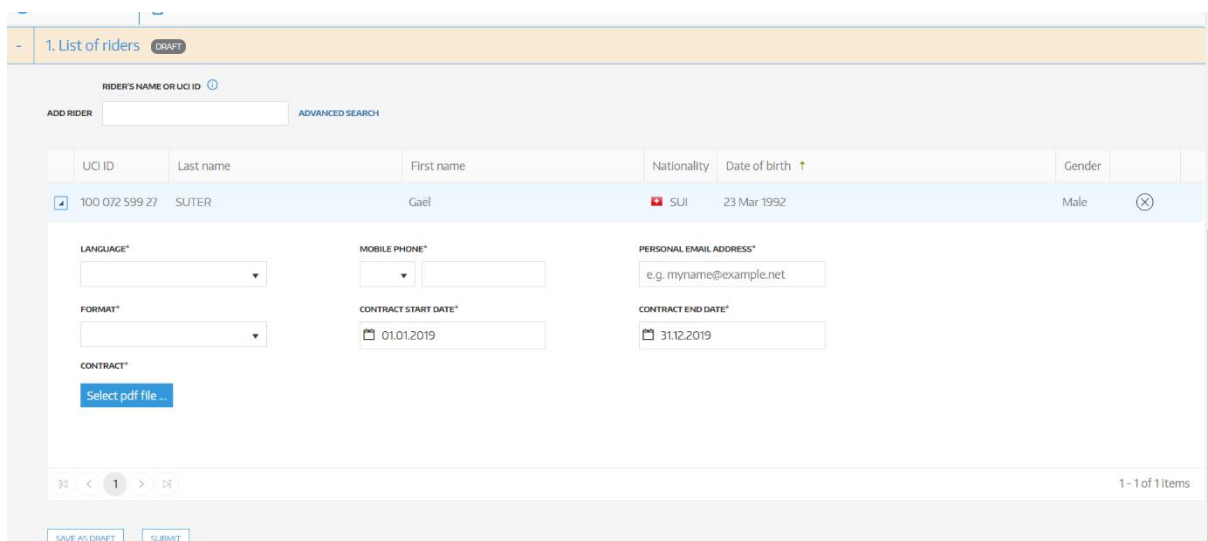
JERSEY DESIGN - 15 JANUARY 2023
